2. OBTAIN A \$ 1,000,000.00 INSURANCE POLICY THAT MUST LIST AS INSURED THE CITY OF FRANKLIN.
3. PRESENT A COPY OF INSURANCE POLICY TO DIRECTOR ONE (1) WEEK BEFORE THE TOURNAMENT.
4. OBEY ALL PARK RULES & RULES LISTED BELOW.

RULES:

1. MUST OBEY ALL PARK RULES.
2. NO ALCOHOLIC BEVERAGES ALLOWED IN PARK.
PLAYERS OR SPECTATORS UNDER THE INFLUENCE OF ALCOHOL WILL

BE REMOVED FROM PARK & TOURNAMENT.

- 3. PERSONS USING VULGARITY AT THE PARK WHETHER PLAYER OR SPECTATOR WILL BE REMOVED FROM THE PREMISES FOR THE REMAINDER OF THE DAY.**
 - 4. A PLAYER OR PLAYERS INVOLVED IN FIGHTING WILL BE REMOVED FROM THE GAME AND PREMISES FOR THE REST OF THE TOURNAMENT.**
 - 5. ANY INDIVIDUAL, PLAYER, OR SPECTATOR INVOLVED IN A THREATENING WAY TO A SUPERVISOR OR UMPIRE WILL BE REMOVED FROM THE TOURNAMENT & THE PARK INDEFINITELY.**
 - 6. NO UNSPORTSMAN LIKE CONDUCT WILL BE ALLOWED.**
 - 7. HIRE OFF-DUTY FRANKLIN POLICE OFFICER.**
 - 8. USE SPORTS PLUS UMPIRE FOR YOUR TOURNAMENTS.**
- PARK HOURS: PARK OPENS AT 8:00 A.M. AND WILL CLOSE WITH LIGHTS OUT BY 10:00 P.M.**
