The City's new **discharge permit** for our **Water Reclamation (Wastewater Treatment) plant** was issued Thursday morning. The new five-year permit will become effective July 1, 2017. It covers both the existing operations at 12 million gallons per day capacity, and the expanded, upgraded facility at 16 million gallons per day. I want to thank our team for their tireless work on this permit over the past several years. The City's goal is to be protective of the river. The Water Management Department already exceeds our water quality requirements and we will continue to exceed the expectations of this new permit. The city will continue our good stewardship of the environment and the Harpeth River.



On Thursday at the **Downtown Franklin Association (DFA) meeting**, Mars Petcare handed out the tool kits to more than 85 downtown retailers who are participating in the **Better Cities for Pets pilot program**. The businesses are encouraged to make pets welcome in their establishments or on their patios, offer water in pet friendly dog bowls outside their doors and more. The official launch for the program will be **Friday, June 16 on the square with speeches from Mayor Moore, the CEO of Mars Petcare and**

Kristy Williams of the DFA. Stay tuned for more details.
