RE: Proposed Calendar for FY2012-2013 Budget Process

Purpose

The purpose of this memorandum is to provide the Board of Mayor and Aldermen (BOMA) with information to consider adopting a calendar for the upcoming budget year.

Background

The City historically has put in place a calendar that covers the submission and review of budget documentation for the next fiscal year. Included in the calendar of dates are the departmental presentations to the Budget and Finance Committee, the date of the budget submission to the Board of Mayor and Aldermen, timing of the public hearings of the proposed budget, the dates for readings of the budget and tax rate ordinances, and the effective date of the budget.

Recommendation

It is the recommendation of City staff that the Board adopt the attached calendar for the new budget cycle, allowing staff to begin the process of developing the new budget in a timely manner and scheduling the presentation of the budget to the Board and to our citizens.
